

## DOCUMENTS TO BRING WITH YOU TO A VITA SITE

- Valid photo ID
- Social Security card or ITIN numbers for you and anyone else on your tax return
- Documentation for ALL income from work, Social Security or pensions, including forms W-2, 1099-R
- Education expenses & student loan payments
- Total amount paid for child care. Bring day care provider's address and tax ID number
- Bank routing and account numbers to direct deposit your refund
- Copy of mortgage 1098 form and receipt of property taxes paid
- Copy of last year's federal and state returns if available
- Access CT forms, 1095A
- Copy of Health Insurance Forms 1095B, or C

## DOCUMENTOS QUE USTED DEBE TRAER A UNO DE LOS CENTROS VITA

- Identificación con foto válida
- Tarjeta de Seguro Social o número de identificación de empleo para usted y otros miembros aplicables con usted
- Evidencia de TODOS sus ingresos, incluyendo seguro social, pensión y las formas W-2, 1099-R
- Evidencia de todos sus gastos educativos y prestamos estudiantiles
- Cuidado de niños que no está pagado en total. Traiga el nombre del Proveedor y su dirección. Y su número de indentificación de impuestos.
- Número de cuenta de cheques y ahorros para que se le pueda depositar en una cuenta o en ambas cuentas.
- Evidencia de gastos de hipoteca y sus intereses
- Copia de reembolso de impuestos federales y estatales del año pasado si los tiene disponible.
- Formas de Access CT, 1095A
- Copia de las formas 1095B o C del seguro de salud
