- Documentation for ALL income, Social Security or pensions, including forms W-2, 1099-R
- Education expenses & student loan payments, 1098T
- Payments for child care. Bring day care provider's address and tax ID number
- Bank routing & account numbers to direct deposit your refund
- Mortgage 1098 form & receipts of property & car taxes paid
Mortgage expenses and/or interest paid
- Access Health CT forms, 1095A, copy of health insurance form 1095B or C
- Identity theft PIN # if applicable

—ONLY IF FILING FOR 2021—

- Economic Impact Payment amount or Letter 6475 from IRS
- Advanced Child Tax Credit amount or Letter 6419 from IRS

IRS refunds including tax credit payments such as the Earned Income Tax Credit (EITC), and the Child Tax Credit/Additional Child Tax Credit will be issued after **Mar. 1st** this include returns being processed at paid preparer locations.
